- Female
- Filipino citizen
- Incoming first-year, second-year, or third-year college students for SY 25-26. Incoming fourth-year students for SY 25-26 may apply only if they take a five-year course. <u>Students expecting to graduate from SY 25-26 are not eligible to apply.</u>
- Will enroll in a public or state university/college for SY 25-26
- Without any existing scholarship
- Have a minimum GPA of 85% (or equivalent)
- Demonstrate financial need
- Be an active member of her community
- · Without any disciplinary or administrative cases
- Aspires to bring positive change to society
- Be a model of integrity in the community
